The minimum turnover is required Rs. 1 crore in each year during preceding 03 years i.e. 2016-17, 2017-18 and 2018-19, as per the Clause 1.5 of the general conditions in the tender document. If there is any consortium, the turnover of both the firms will be included to calculate the minimum turnover of Rs. 1 crore each year.
8.	GST – Security Deposit amount will be deposited by the 2 <sup>nd</sup> Party equivalent to 03 months license fee with GST. Whether GST on irrevocable performance guarantee is applicable, if yes, do we get security refund with tax and do we have to show this tax separately in these books.  The award of contract is for renting out for Socio Cultural Function but can the exhibitions be also organized on these plots.	GST is not applicable on security deposit/performance guarantee. Hence, the Security Deposit will be the amount equivalent to three months' license fee. GST will not be taken into consideration on the security deposit amount. 14.	Is it necessary to quote the bid for both plots?	No, it is not necessary for the bidder to quote the bid for both plots. He may quote the bid as per his requirement for one plot or both plots. But the plots will be allotted separately to the H-1 Bidders.  Please also refer Clause No. 2 of the General Conditions of the tender document for further clarifications
