CORRIGENDUM

This is in reference to the "Eligibility" provided under "General Terms & Conditions" of the above mentioned tender document as per point No.4 and 6 which is reproduced hereunder-

Point no. 4

A the time of applying for the stall in DHINA, the bidder will declare that he/she and his/her family members do not have any kiosk/shop/stall/PCO booth in Delhi under any scheme of Government of Delhi under the handicapped quota.

Point No. 6

At the time of applying, he/she should not have availed the benefit of reservation for PwBD under any other Government Scheme of similar nature, i.e, Allotment of shops, kiosks, stalls etc.

In this regard, it is clarified that if a stall has been allotted till 30.09.2023 and will not be in the possession of bidder after 30.09.2023 in such cases the bidder is eligible for applying/bidding subject to fulfillment of other conditions of the tender document.

Accordingly, Point No.2 of the Affidavit (Annexure B) to be submitted by the bidder is hereby amended in view of above clarification, as under –

Existing point

"That at the time of applying, I & my family members do not have any kiosk shop/ stall/ PCO booth in Delhi under the scheme of Government of Delhi under handicapped quota."

Revised Point

"That at the time of applying, I & my family members do not have any kiosk shop/ stall/ PCO booth in Delhi and I & my family members will not have any kiosk/ shop/ stall/ PCO booth in Delhi other than the kiosk in Dilli Haat INA, (if allotted) w.e.f 1.11.2023 under the scheme of Government of Delhi under handicapped quota." (Please strike off whichever is not applicable)

Accordingly, the Affidavit (annexure B) of the tender document is hereby amended as per revised Affidavit (Annexure B) enclosed herewith.

All the bidders are required to submit the revised Affidavit at the time of applying/submission of bids.

The financial bid evaluation criteria is also revised as under:-

Existing Criteria

Where; Sfis the Financial Score

FH is the value of the highest commercial bid
F is the price quoted in the bid under consideration
