acceptance for regular promotion on the occurrence of vacancy, subsequently. In case yone refuses to accept the higher post on regular promotion subsequently, he/she shall be subject to normal debarment for regular promotion.

All the regular Helper/Attendant, Utility Worker, Dish Washer and Security Guard will be re-designated as Office Assistant-cum-Helper/Attendant, O.A.-cum Utility Worker, O.A. cum Dish Washer and Office Assistant-cum-Security Guard, in view of the DTTDC Office Order No. PER/1424/3/92/DTTDC/PF-II/1545 dated 5.5.2010.

The above officials are entitled to the merely placement on personal basis in the higher pay scale/grant of financial benefits only and shall not amount to their actual/functional promotion.
