The grant of financial up-gradation on personal basis will entitle the incumbents for various pay-linked benefits such as various allowances, House Building Advances, other advances etc.

These officials are hereby directed to give their option for pay fixation under the provision of FR 22 (1) (a) (1), either to fix their pay from the date of grant of financial up-gradation or from the date of their date of increment. Their option should reach the Personnel Division within one month from the date of issue of this Order. In case no option for pay fixation is received, the pay of the concerned employee will be fixed w.e.f the date of grant of financial up-gradation. The financial benefit allowed to the above officials under the Scheme shall be final and no pay fixation benefit will accrue to them at the time of regular promotion, i.e. posting against a functional post in the higher grade.
