**Terms and Conditions for allotment of stalls through e-auction in DilliHaat INA**

1. The allotments shall be made to the highest bidder irrespective of any situation related to network issue.
2. The bidders are advised to visit the site before bidding & bring the material/goods as per size of stall on as is where basis.
3. The bidder will be liable for his/her technical fault & DTTDC will not be responsible.

**A. Eligibility of Bidder/Documents required**

The following documents are required to be submitted by the bidder on portal along with the Application form (Eligibility Criteria).

1. One passport size photo of Artisan.
2. Copy of valid Artisan Card issued by Ministry of Textiles, Government of India/State Govt.
3. PAN Card Number of Artisan.
4. Aadhar Card for ID Proof of Artisan.
5. E-Auction Application Form duly filled up in by Artisan along with required documents.
6. Proof of Security Deposit of Rs.1,00,000/-
7. Only one member of the same family can participate in the e-auction. If more than one application is found in the e-auction process of the same family in the same quarter, no application will be considered.
8. Goods and Service Tax Number

If found guilty of any of the above compliance, action can be taken by DTTDC and all expenditure can be recovered from the agency.”

**Undertaking as per Annexure-1**

**B. Earnest Money Deposit (EMD)**

1. An EMD must be of Rs.1000/- Plus the Reserve Price (Reserve Price+Rs.1000/-) is required to be deposited with DTTDC/DHINA. A copy of the demand draft or RTGS details favoring M/s DTTDC Ltd. towards EMD will be attached and uploaded along with the application form.
2. Separate DD/RTGS for each bid/stall will be submitted by the bidder. It will be mandatory for the bidder to make payment (either through RTGS or DD) only from his/her own bank account. In case EMD is received from a person, other than the bidder, the request/form of the bidder shall stand rejected without assigning any reason.

4. The Bank Details are **DTTDC Ltd., PUNJAB NATIONAL BANK (P.N.B); A/C- 3978012100000010, IFSC CODE-PUNB0614800; PAN-AAACD0169J; GST no.07AAACD0169J1ZS**
5. The original Demand Draft/ Banker's cheque must be submitted with DHINA (DilliHaat INA Authorities) before starting of bidding process failing which the bidder would not be allowed to participate in the bidding process.
6. The entire amount of bidding plus GST is to be deposited before taking over possession of the stall in each month. In case, the bidder fails to deposit balance amount before taking over the possession he/she will not be allowed to open the shop. If the bidder fails to deposit the amount within three days of the auction date, failing which the EMD will be forfeited without notice to the Successful Bidder. This will become reason for DTTDC to debar the Successful Bidder from participating in the future auctions for a period to be decided by DTTDC.
7. The EMD kept with DTTDC of Successful Bidder shall be will be adjusted only in the last month of the allotment period.
8. Further if the bidder has applied of bid for in his/her name and one of the bids is H-1, the earnest money of the bid amount which is not H-1 bid, will also be adjusted from the due amount payable by the highest bidder.
9. The EMD of unsuccessful bidder will be returned after 30 days without interest.

### **C. Security Deposit**

10. **An additional Security Deposit of Rs.1,00,000/- (Rupees one lakh only) is required to be deposited with DTTDC/DHINA. A copy of RTGS or DD favoring DTTDC Ltd. towards security deposit will be attached or uploaded along with application form. The security will be refunded without interest after taking physical possession of the Staff by DTTDC from allottee upon completion of allotment or shall be adjusted towards the dues if any and balance if any shall be refunded, upon completion of allotment period.**
11. **If the successful bidder surrenders the stall, the security deposit and EMD both will be forfeited.**
12. The vendors can deposit security amount of Rs.1,00,000.00 (Rupees One Lakh) in the form of DD/Fixed Deposit/Bank Guarantee in favour of DTTDC Ltd. Security amount must be from the bank account of the bidder only in whose name stall is allotted. The duration of Fixed Deposit/Bank Guarantee must be more than two months over and above the allotment period of a stall (For example - in case the stall is allotted for three months, validity of Fixed Deposit/Bank Guarantee should be at least for five months.) In case the vendor gets the stalls in next auction process, he/she would be required to submit fresh fixed deposit/ bank guarantee.
13. In case vendor deposits full rent of the period of allotment along with electricity charges in advance before taking over the possession, such vendor would not be required to deposit this security amount.
14. In case, the allotment of stall is for more than one month, the bidder will deposit rent of the stall for second

and subsequent months 10 days before expiry of the existing month.

15. One bidder can apply maximum of only one stall. In case, any bidder is found to have got allotted more than one stall, the allotment with the lower bid amount out of all allotted stalls by the said bidder will be treated as cancelled and the EMD amount will be forfeited.
16. Bidders must have a valid GST registration with specified items to be sold in DilliHaat INA. The registration must be provided in the Bid documents, failure to which the Bid will be rejected.
17. In case Bids are not received against two reserved stalls C1 and TI in first e-auction then in the second e-auction of the same period, the reserved stalls will be considered in general category i.e. Handicraft and Handloom
18. In case of quoting wrong amount by the bidder in the bidding for any reasons whatsoever, DTTDC/DHINA will not be held responsible and in case the bidder chooses not to take the stall after quoting the rates (being H-1) due to any reason whatsoever the EMD will be forfeited. If the similar error is repeated in the next two bids then the party will be totally debarred for next two quarters and will not be allowed to bid for next two quarters.

#### **D. Operation of the Stalls**

19. Only authorized assistant appointed by crafts person/bidder is allowed to sit in their allotted stall. ID proof in the shape of Aadhar card/driving license/passport with police verification etc. is mandatory for the authorized person/assistant to be submitted.
20. That the allottee shall make payment to DTTDC in all account including but not limited to License Fees only from his/her own Bank Account. In any case, no third party, payment shall be accepted. The payments to DTTDC shall be only through banking channel i.e. RTGS/NEFT/Demand Draft/Banker's Cheque. No cheque or cash will be accepted.
21. Crafts person/bidder and their assistants are advised to make their ID card/Entry card from DHINA before taking possession of the stall.
22. In case of emergency in general or emergency with allottee, the crafts person/bidder are required to either close their stalls or appoint their assistant to sit in the allotted stall and shall take care of their belongings/products for which DHINA/DTTDC shall not be responsible for any loss or damages suffered by the allottee.
23. For all the times, the allottee shall keep their personnel and belongings/products insured from any loss against Fire, Theft, Burglary, Riots or any other natural calamity for which the DTTDC/DHINA shall not be responsible for any loss or damages suffered by the allottee.
24. No original allottee will sublet his/her stall to any other person. If found, the original allottee will be blacklisted for a period of **two quarters** and rental /security / his goods will be confiscated at the allottee's own risk and cost. This shall include change in the Management of allottee in case the allottee is Partnership Firm or Company i.e. change in partner shall not be allowed and change in Directors/Equity Shareholders shall not be allowed.

25. After the bidding process is complete. DTTDC/DHINA shall be entitled to investigate the issue of cartelization if any being made by the bidders who participated in the bid process and for the same, the bidders shall have no objection and must provide the documents including bank statements etc. or call records or emails, whatsapp chat record etc. to investigate the issue upon demand of DTTDC/DHINA. If it is found to be true the DTTDC shall cancel the allotment of the Successful Bidder who got advantage of the said cartelization.
26. The allottee will not be allowed to surrender the stall during the period of allotment in any case. In case any allottee leaves the stall in between the allotted period, the security deposit will be forfeited and he/she will be barred for next two quarters for e-auction/bidding of the stall.
27. Shifting of stall by the allottee from one place to another place will not be allowed. However, DTTDC/DHINA may shift the stall from any place due to any exigency, for which vendor/operator will have no objection.
28. The stall has to be vacated on the last date in any condition (mentioned last date).
29. **Artisans are allowed to participate only once in a six months in e- bidding (w.e.f. 01.01.2025).**

#### **E. Encroachment and occupation of excess space**

30. The allottee will not be allowed to occupy extra area beyond the prescribed allotted area. The allottee will be liable to close the stall in case Dilli Haata authorities observe any encroachment.
31. Prescribed display area of 3 ft. as marked in front of stalls will be utilized by the artisan for display purpose only. If encroachment/occupation of space beyond display is noticed, a penalty of Rs.1000.00, Rs.1500.00 and Rs.2000.00 per day would be levied for first, second and third time respectively along with confiscation of displayed items on every occasion by DTTDC at the risk and expense of the artisan. Fourth time allotment of stall for next two quarters. The display area can be removed by DHINA/DTTDC at any time in view of any exigency.

#### **F. Sale of Specific items**

32. Crafts person/bidder is allowed to sell their products only as mentioned in Artisan card. Any violation may attract closure of the stall/imposition of penalty as prescribed under terms & conditions/forfeiture of rent and security deposit/blacklisting or any other action as may be deemed fit. If bidder fills up the product, in the form, other than as mentioned in his/her artisan card, form will be rejected without assigning any reason.
33. Allottee shall not be allowed to sell any product or goods prepared/manufactured outside India i.e. only Swadeshi products/goods shall be sold, failing which the allotment shall be terminated with forfeiture of security amount.
34. Highly inflammable goods/items shall not be kept in the stall for any purpose including but not limiting for sale / show case the same.

#### **G. Electricity and maintenance of the stall and surroundings**

35. Electricity charges of Rs.5000 excluding GST per quarter per stall will be charged for maximum 06 bulbs of 40W only for each stall. The charges will be paid by the bidder

before occupying the stall. For more than 06 bulbs, Rs.1000 per bulb will be charged for which vendor or will take prior approval. And if the extra bulb is used without the approval of the authority, then Rs.2000 will be charged for each extra bulb towards penalty. Bulbs are to be arranged by the allottee himself/ herself.

36. Lights and Fans are available in each stall and should be switched off before closing the stall. The bidders are advised to use the light as per minimum requirement in day time to save the power consumption.

#### **H. Behavior with visitors**

37. Crafts person/bidder should keep good behavior with the visitors.
38. The bidder allotted the stall will take all precautions to avoid any complaint of visitors. If any complaint is received from visitors and after examination it is found that there is merit in the complaint, DTTDC will take appropriate action which may include imposition of penalty up to Rs.10,000/-, closure of the stall, forfeiture of rent and debarment from bidding in future for two quarters, against the allottee depending upon the seriousness of the complaint.

#### **I. Timings**

39. Crafts person/bidder are required to be available in their allotted stalls (11 AM to 09:00 PM). Stalls will be closed in their absence. In case of any change in timings due to any reasons at any point of time, the bidder would be required to follow it without any liability on DTTDC/DHINA.
40. Crafts person/bidder should maintain cleanliness in and around DilliHaat and co-operate with DilliHaat authorities in maintaining cleanliness and decorum of DilliHaat INA. No item will be kept in green areas/planters.

#### **J. Miscellaneous**

41. DilliHaat INA is a No Smoking Zone/No Plastic Zone.
42. Only one member of the same family can participate in the e-auction. If more than one application is found in the e-auction process of the same family in the same quarter, no application will be considered.
43. Crafts persons/bidders are under obligation to strictly adhere to this especially the ban on use and storage of single use plastic material.
44. The DTTDC/DilliHaat INA reserves the right to cancel the bidding process/allotment at any time without assigning any reason.
45. No refund/relaxation in rent will be done in case of closure of DilliHaat due to instructions from the Government of Delhi/India and any statutory and government body.
46. The operators of the stalls will strictly follow the Covid guidelines/health related guidelines /any other guidelines or orders issued from time to time by the authorities/local government/government.
47. The successful bidder should keep ABC powder type 6 kg fire extinguisher at a town cost for safety point of view. The fire extinguishers should be replaced before its expiry date.

48. All payments towards EMD, Rent, Electricity, Security Deposit and penalty will be made by the bidder from his/her own bank account.

**K. Relaxations**

49. MD & CEO, DTTDC is the competent authority to relax any of the above conditions in special circumstances. In case of any dispute with regard to any item to be sold from the stall, the decision of the competent authority would be final. In case of any overlapping and/or any clarity in any of the clauses/ conditions, the decision of the competent authority will be final.

**L. Undertaking by the Bidder**

I agree upon the above terms & conditions. I will strictly follow the rules and regulations of DilliHaat INA. I will be liable to face necessary action against me, if found to be a defaulter.

**M. No Responsibility for Loss or Damage:**

50. DTTDC, its officials, employees, and representatives shall not be liable or responsible in any manner whatsoever for any **loss, theft, burglary, fire, electrical short circuit, explosion, sabotage, scuffle, physical assault, riot, dacoity, civil commotion, water damage (including seepage or leakage), storm, flood, earthquake, lightning, accident, structural failure, pest infestation, or any other unforeseen incident** resulting in damage to life, limb, stock-in-trade, equipment, fittings, installations, or any other property belonging to the allottee, their staff, or third parties, whether occurring during, before or after the allotment period.

**N. Occupancy Entirely at Allottee's Risk:**

40. Allottees shall occupy, operate, and use the allotted stall **entirely at their own risk**. The DTTDC will not accept or entertain any insurance, damage, compensation, or injury-related claims. Allottees are strongly advised to take comprehensive insurance coverage for their stock-in-trade, personnel, equipment, fittings, and third-party liability.

*Absolute Waiver of Claims:*

The allottee expressly waives and discharges DTTDC and its functionaries from **any and all present or future claims, demands, suits, legal actions, or proceedings**, whether civil or criminal, arising directly or indirectly from any such event, regardless of cause.

**O. Strict Responsibility for Electrical Installations:**

41. The allottee shall ensure that all **electrical wiring, plugs, extension cords, and appliances used in the stall** are ISI-certified and in compliance with prescribed safety standards. Any use of unauthorized electrical fixtures or overloading shall be at the risk of the allottee. DTTDC shall not be held responsible for fire or damage arising from such causes, and **any resultant damage to DTTDC's property shall be recoverable from the allottee**.

**P. Mandatory Fire Safety Compliance:**

42. Each allottee must **maintain one functional 6 kg ABC-type fire extinguisher** within their stall at all times. The extinguisher must be replaced or recharged before its expiry. Failure to comply shall attract **immediate penalties, cancellation of allotment without refund**, and possible blacklisting for future auctions.

**Q. Indemnity Clause:**

43. The allottee shall **indemnify, defend, and hold harmless** DTTDC, its officials, employees, and agents from **any third-party claims, lawsuits, damages, penalties, losses, or legal expenses**, including attorney's fees, arising out of:
- any act or omission by the allottee or their staff;
  - damage to DTTDC's property due to negligence or willful misconduct;
  - injury or harm caused to visitors or vendors;
  - any breach of the terms and conditions of allotment.

**R. No Subrogation Allowed:**

44. Any right of subrogation by the allottee's insurer against DTTDC or its employees is expressly prohibited.
