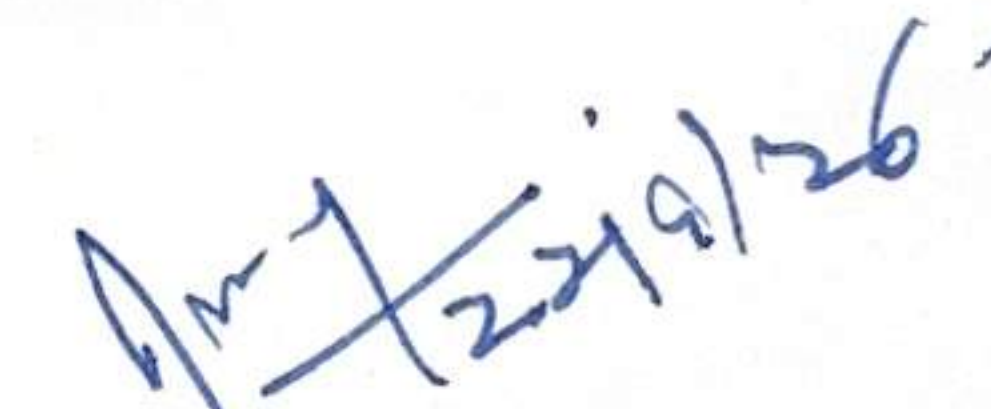
4.0 The Shop Incharge shall be responsible for any discrepancy which may come to the notice of management subsequently.

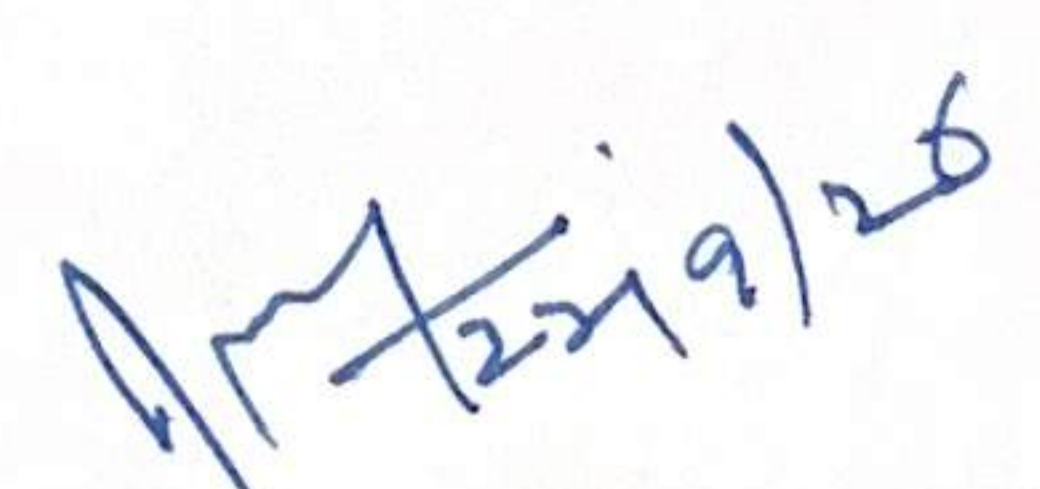
